a) Describe the project associated with the listed activities applied for

CC Chickens is proposing the expansion of poultry abattoir capacity to slaughter an additional 30 000 chickens per day on Elfdeweg no 26, Kroondustria, Erf nr: 00007819 situated in Kroonstad District within Moqhaka Local Municipality area. The need for a Basic Assessment is triggered by Listing 1; activity 38(i) in GN R327 dated 4 December 2014 and amended on 07 April 2017. The total area of the proposed project is 12 246m^{2.} The site is located on an area that has an existing poultry abattoir. The project will entail the following:

• The activity will entail the expansion an existing abattoir 12 246m² with the capacity to slaughter a throughput of 50 000 poultry per day to slaughter an additional 30 000 poultry per day. The abattoir maximum capacity will be 80 000 after expansion. The footprint of the abattoir will remain unchanged, and capacity will be increased by the upgrading of equipment used inside the existing building.

The site is fenced off with a 1.8m electric fence.

The Moqhaka Local Municipality is a Category B municipality situated within the southern part of the Fezile Dabi District in the Free State Province. It is the largest of four municipalities in the district, making up over a third of its geographical area. The former Kroonstad, Steynsrus and Viljoenskroon Transitional Local Councils and sections of the Riemland, Kroonkop and Koepel Transitional Rural Councils are included in the municipality. The seat of local government is Kroonstad. The community name is the south Sesotho word for 'crown'.


